\_\_\_ **Group Play** - All dogs must pass a general behavior assessment in order to attend doggy daycare. No dog may be admitted to the doggy daycare who shows any signs of any type of aggression. Owner further understands and agrees that in admitting Owner's dog(s) to dog-dog group play, Owner is representing to Sublime Pet Spa that Owner's dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dogs. Any dog demonstrating aggression or other behavior deemed unacceptable by Sublime Pet Spa's staff may be required to leave doggy daycare.

\_\_\_ **Risk of Injury** - I understand, acknowledge and assume the inherent risks, foreseeable and unforeseeable, that may arise from my dog's exposure to other dogs and other environments, including the risk of illness, injury and death (collectively "Injury"). Despite health requirements and proper animal handling, preventative measures may be inadequate to prevent Injury from the actions or inactions of other dogs, my dog, and/or Doggy Daycare. I specifically acknowledge the risk of Injury arising from interactive play with other dogs, during which my dog could inflict or suffer injury to/from another dog. Unless the result of Sublime Pet Spa & Doggy Daycare's gross negligence or intentional misconduct, I assume full and sole responsibility for my dog's participation in all activities at Doggy Daycare and any Injury my dog or I sustain.

\_\_\_ **Vaccinations** - I acknowledge that vaccines do not protect against all communicable illnesses that may affect my dog(s). I confirm that my dog(s) has/have not been exposed to any contagious diseases within the past thirty days and I certify that my dog(s) is/are in good health and is/are up to date on all vaccinations (Bordetella, Rabies, Distemper, and Influenza), is/are on flea medication, and has/have had a negative fecal and a negative heartworm test in the past year. Should a dog be observed to have fleas or ticks, a flea/tick bath treatment will be applied and the owner notified. The medicated bath will be at the expense of the owner at a rate of up to \$80.00 depending on severity and size of dog.

\_\_\_ **Emergency Care for My Dog** - If my dog experiences any medical problems while in the care of Sublime Pet Spa & Doggy Daycare, I authorize them to do whatever they deem necessary for the safety, health, and well-being of my dog, and I further agree to assume full financial responsibility for any and all expenses incurred.

\_\_\_ **Food/Medication** - While attending the doggy daycare, I agree that it is my responsibility to bring any food and medications for my dog(s) while they are in Sublime Pet Spa's care. There is a \$5 feeding charge and a \$5 medication application fee that will be added to the owners bill.

\_\_\_ **Payments** - Payments are due and payable at the end of each visit. Payment may be made in cash, Visa, Discover, American Express or Master Card. There is a 4% service charge if paying with a credit card.

Cancellations / No-Show Policy: Cancellations must be done 48-hours prior to reservation date. If there is a consistent number of cancellations Sublime Pet Spa reserves the right to discontinue services.

Closing time: I agree that if my dog(s) is/are not picked up by closing time of 6:00 p.m. there will be a \$25 late fee added to the owner's bill.
